## Proper use

#### **△ WARNING**

The appliance is not suitable for vacuuming dust which endangers health.

- The machine is meant for dry and wet cleaning of floors and walls.
- This appliance is suited for the commercial use, e.g. in hotels, schools, hospitals, factories, shops, offices, and rental companies.

## Start up

## Dry vacuum cleaning

#### **ATTENTION**

Risk of damage! For dry vacuuming, the cartridge filter must always be installed.

 To vacuum fine dust, you can also use an additional paper filter bag.

#### Inserting the paper filter bag

Illustration B

- → Release and remove the suction head.
- → Insert the paper filter bag.
- → Insert and lock the suction head.

#### Wet vacuum cleaning

#### Inserting the rubber lips

Illustration C

- → Remove the brush strips.
- → Install the rubber lips.

**Note:** The structured side of the rubber lips must point outwards.

#### Remove the paper filter bag

 To suck wet dirt, first remove the paper filter bag.

#### Installing an additional filter

- → Release and remove the suction head.
- → Turn the suction basket by 180° and keep it aside.
- → Loosen the mounting nuts
- → Remove the cartridge filter.

Illustration **D** 

- → Insert the fastening nut and tighten it.
- → Install the additional filter.
- → Insert and lock the suction head.

#### Clip connection

#### Illustration **I**

The suction hose is equipped with a clip system. All C-35/C-DN-35 accessories can be connected.

## Operation

## **Turning on the Appliance**

- → Plug in the mains plug.
- → Switch on the appliance at the main switch.

## **Emptying the dirt container**

- The vacuum channel is equipped with a float.
- When the dirt water reaches the highest permissible level in the container, the suction power is interrupted.
- → Switch off the appliance at the main switch.

#### Illustration **F**

→ Drain off dirty water through the drainage hose.

6 EN – 2

#### Turn off the appliance

- → Switch off the appliance at the main switch.
- → Pull out the mains plug.

#### After each operation

- → Empty the dirt container.
- → Vacuum and wipe the appliance inside and outside with a damp cloth.

#### **Storing the Appliance**

#### Illustration G

- → Store the suction pipes, the suction hose and the mains cable as shown in the illustration.
- → Place the appliance in a dry room and secure it from unauthorized use.

## **Transport**

#### **△** CAUTION

Risk of injury and damage! Observe the weight of the appliance when you transport it.

#### Illustration III

- → Transport the appliance as shown in the illustration.
- → When transporting in vehicles, secure the appliance according to the guidelines from slipping and tipping over.

## **Storage**

#### **△** CAUTION

Risk of injury and damage! Note the weight of the appliance in case of storage. This appliance must only be stored in interior rooms.

## Care and maintenance

#### **△** DANGER

First pull out the plug from the mains before carrying out any tasks on the machine.

## Change cartridge filter

- → Release and remove the suction head.
- → Turn the suction basket by 180° and keep it aside.
- → Loosen the mounting nuts
- → Remove the cartridge filter.
- → Insert the new cartridge filter.
- → Insert the fastening nut and tighten it.
- → Insert and lock the suction head.

## **Troubleshooting**

#### **△** DANGER

First pull out the plug from the mains before carrying out any tasks on the machine.

#### Suction turbine does not run

- → Check the receptacle and the fuse of the power supply.
- → Check the power cable and the power plug of the device.
- → Turn on the appliance.

# Vacuum turbine is running but the machine is not sucking in dust/dirt

- Float is blocking the suction canal.
- → Empty the dirt container.

#### Suction capacity decreases

- → Remove choking of suction nozzle, suction tube, suction hose, or cartridge filter.
- → Exchange the paper filter bag.
- → Change cartridge filter.

## **Dust comes out while vacuuming**

- Check the proper installation of the cartridge filter.
- → Change cartridge filter.

#### **Customer Service**

If malfunction can not be fixed, the device must be checked by customer service.
